Refund Policy for session 2024-25

For General Admissions

Application for the refund of Tuition Fee and Transport Fee received before the last date of applying refund will be accepted and thereafter no application for refund will be accepted.

1. Refund of Tuition Fee/ Hostel Fee/ Transport Fee

a) Withdrawal before the start of session

In case an applicant withdraws before the start of the session then the amount already deposited by the applicant, after the deduction of processing fee of Rs.3000/- per head shall be refunded.

b) Withdrawal after the start of session

In case an applicant withdraws after the start of session then the amount already deposited by the applicant, after the deduction of processing fee of Rs.3000/- per head and $1/5^{th}$ of the total tuition fee, $1/10^{th}$ of the hostel fee and $1/5^{th}$ of the transport fee shall be refunded.

- **2.** If a student was earlier admitted to a programme but later on transferred to some other programme having lesser tuition fee, then for the calculation of deduction for the purpose of refund of tuition fee, the fee of the programme in which applicant was originally admitted (before programme transfer)will be considered.
- **3**. For the purpose of refund processing, the date of commencement of classes, will be considered as date of the start of the session.

4. Refund for Package Fee cases

If the candidate opted package fee then the refund will be applicable as per the following terms and conditions:

a) Withdrawal before the start of session

In case an applicant withdraws before the start of the session then the amount already deposited by the applicant, after the deduction of processing fee of Rs.3000/- per head shall be refunded.

b) Withdrawal after the start of session

For Direct Admission: In case an applicant withdraws after the start of session then the amount already deposited by the applicant, after the deduction of processing fee of Rs.3000/- per head and $1/4^{th}$ of the total tuition fee plus Hostel fee will be deducted and rest of the amount will be given back to the candidate.

For Example : If the 1st Installment of any X-Y course is Rs. 2,60,000/- then after deduction of processing fee of Rs. 3000/- plus 1/4th of the 1st Installment, rest of the amount will be refunded.

For Admission Through Consultant: University will be responsible for the amount deposited in the University account, whether through consultant or by candidate. After deduction of 1/4th of the deposited amount the rest of the money will be refunded.

For Example: If the Ist Installment of any X-Y course is Rs.2,60,000/- and candidate deposited Rs. 1,10,000/- in the University account and Rs. 1,50,000/- given to the consultant. Then University is answerable only for 1,10,000/- which is deposited in the University and after deduction of $1/4^{th}$ amount from 1,10,000/- , i.e Rs.27,500/- Rs. 82,500/- will be refunded to the candidate.

5. Non-refundable fees/cases

- a) Amount paid for obtaining Prospectus, Application fee, Processing fee, Entrance fee, Late fee, Programme Transfer Fee, Migration fee, uniform fee etc. is non-refundable under all circumstances, unless in specifics are prescribed as refundable.
- b) In case a fresher student leaves after the laps of refund date or withdraws/leaves in the midstream, in such cases, that student shall have no claim of refund of fee & other charges already paid.
- c) If in case, a candidate has unknowingly or wilfully concealed or suppressed any information/fact or uses any fraudulent means for getting the admission to the university or for obtaining scholarship, admission of such an applicant shall be cancelled. That candidate shall have no claim of refund of fee & other charges already paid.

6. Procedure of refund

- a) For refund, applicant needs to apply to the university on the prescribed form as available in the university campus.
- b) Only original form duly filled & signed by the candidate and parent/guardian received in person or by post/email before the last date of refund will be accepted and thereafter no application of refund will be accepted.
- c) For postal delay, university will not be liable for the refund.
- d) Refund will be made only after the return of original id card, fee receipt, letter from university to apply loan (if any) or any other document required at the time of refund.
- e) Refund will be made only in the form of A/c payee cheque in the favour of concerned student or parent as opted and written by the student while filling the application form for refund.
- f) Once the application for refund has been submitted, then for any request to change the name of payee (student/parent) or for the request to reissue the cheque, an additional processing fee of Rs.500/- will be charged.
- g) In any case, amount refunded will be in Indian currency only.
- h) No interest is payable on any amount deposited with university.
- **7.** It will take 5 to 6 working weeks to process the Refund case.
- **8.** 15th Sept. 2024 will be the last date for applying refund.

For PhD Admissions

There will be no refund for PhD Admission registration fee, course work fee or Semester fee paid by the candidate in any case. So admission amount in PhD cases will be totally non refundable.
